Report on the Financial Statements

We have audited the accompanying financial statements of _M/S PARAMBIKULANGARA SREE VILASINI SABHA KURIES LIMITED, THRISSUR which comprise the Balance Sheet as at 31st March, 2024, the Statement of Profit and Loss, for the year then ended, and a summary of the significant accounting policies and other explanatory information.

Management's Responsibility for the Standalone Financial Statements
